


# New for 2023 - The East Midlands Branch

At meeting ONE there is going to be a lot to take on board; reading this will hopefully start to provide a foundation for questions you might have while attending for the first time on February 1st.

## **What is this new branch?**

The new Equity branch in the East Midlands is an important development for the union and its members in the region. It will provide local representation and support for members, who will have access to branch officers and regional representatives who can assist them with issues such as contracts, health and safety, and employment rights. The branch will also provide opportunities for members to network and engage with their peers, enabling them to share knowledge and experiences, as well as stay informed about industry developments and opportunities. In addition, the new branch will allow Equity to better serve its members in the East Midlands and ensure that their voices are heard on issues that matter to them.

## **What is the role of a Branch?**

The role of a branch is to

1. provide a local forum for members to discuss, organise and campaign on issues relevant to their members
2. provide a channel of communication between members and the Council
3. propose motions for consideration at conference to the Union's annual regional and national meetings
4. send representatives to the annual conference.

## **Running a Branch.**

To manage the branch and help fulfil this role members of the Equity branch in the East Midlands elect a committee. Branch committees can be not less than five and no more than nine members who must all in full union membership benefit. One of the nine seats is reserved specifically for a member engaged in variety, cabaret, burlesque, circus, story-telling and similar entertainment.

The committee then designates among itself the following roles Chair, Secretary, Treasurer, Campaigns Officer and Variety Officer. There are 6 specific roles and 9 committee members. In the past branches have created roles such as Diversity, LGBT, Accessibility, Events, Press Officer and Web Master. The remaining seats can simply be general seats with no specific responsibility.

In addition to electing a committee the branch can send TWO representatives to the annual conference which this year takes place in London from Sunday 21 – Monday 22 May.

**You are invited to be a founding member of the East Midlands Branch of Equity.**

Remember this is a brand new branch, no outgoing committee just you and your fellow union members who have lived and resided in the East Midlands region of the United Kingdom for part or all of your professional career.

There is however a legacy we should not forget and that is the Variety Branches who championed and represented the region's interests prior to Jan 1st 2023.

Every East Midland Equity member is starting as a new member of this branch. If you are a seasoned professional or just out of training with a shiny new Equity membership card everyone is welcome. Non members are welcome too so +1s are fine and the Equity curious!

## **Staff & Council in the East Midlands**

We are supported by the union's regional organiser, Ian Bayes and connected to the council by an elected member living in the region. Tonia Daly-Campbell is the Midlands Councillor.

Ian started working for Equity in 2000 over the years he has taken on a number of roles, London Area Theatre & Commercial Tours Organiser, BBC Organiser and is currently our Midlands Official.

He has worked with various industrial committees, Independent Theatre, Designers, Fight Directors, Walk-on & Supporting Artists and the Variety Circus & Entertainers Committee. He brings all this experience to us. Ian is currently working with the Street Performers Network.

Tonia is an experienced actor, writer, and director. Is an audience development consultant at the Grand Theatre Wolverhampton and a casting director at Heart Casting. Tonia was elected as our regional councillor in July 2022.

The branch's committee will be a transition committee to steer the new branch until full nationwide committee elections for all 24 branches can be held in the autumn. For the first time in the union's history a centralised timetable for branch committee elections. We don't have to worry about this until later in the year. The immediate priority for all branches up and down the country is the annual conference. There is a timetable.

## **Here are the key dates**

- Jan – Feb: Branches and committees meet to decide on motions.
- Fri 13 – Fri 17 Feb: Emails giving notice of national/regional meetings are sent to all members.
- Wed 1 Mar: Closing date for receipt of motions from branches and committees (12 noon).
- Mon 20 Mar – Wed 5 Apr: National/regional meetings select motions from branches.

... as well as forming a committee at our second meeting we must consider, with the help of our regional organiser Ian Bayes, proposing our very first motion to send to the Midlands Area annual meeting. This meeting will take place between Mar 20 - Apr 5. In the past this has taken place in Birmingham.

With Meeting 1 and 2 under our belt, A committee in place, meeting 3 will be our new horizon.

## **Meeting 3 Wednesday 5th April**

Between meeting 2 and 3 the committee will meet and the East Midlands Branch will be ready to GO.
